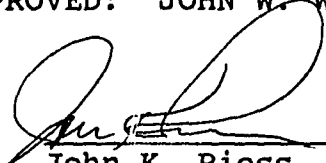

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$206,000 from CIP 52-462.0, TransNet Fund 30300, University Avenue/Lincoln Avenue Two-Way Couplet System and an amount not to exceed \$50,000 from CIP 52-504.0, CapOut Fund 30245, University Avenue - Bancroft Street to Boundary Street, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
