WHEREAS, Council Policy 700-8 does not allow for amplified sound in that area unless the City waives that policy for the event; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that Council Policy 700-8, entitled "Mission Bay Park Policies," pertaining to amplified music concerts in Mission Bay Park, be and is hereby waived, for one time only, for the 1992 "Walk for Children" event being held in De Anza Cove in Mission Bay, on March 7, 1992.
