RESOLUTION NUMBER R-279507 ADOPTED ON MAR 03 1992

WHEREAS, the Council of The City of San Diego (the "City") has previously given its general approval to financing plans for the Southcrest Redevelopment Project Area, of the Redevelopment Agency of The City of San Diego (the "Agency"); and

WHEREAS, the City has adopted the Fiscal Year 1991-92 Capital Improvement Budget; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the Auditor and Comptroller is hereby authorized to accept a loan repayment of \$274,683.73 from the Redevelopment Agency, Gateway Center West Project Area, and to allocate \$274,683.73 of Sales Tax to the Contribution to the Redevelopment Agency (10227); and to appropriate these funds to be loaned back to the Redevelopment Agency, Southcrest Project Area to be used for Mitigation Payments to National City related to the 252 Corridor, and costs for administering the project area.
- 2. That the City Manager is hereby authorized to submit an amendment to the 1990 Community Development Block Grant ("CDBG") Statement, reallocating \$1,400,000.00 for the Section 108 loan repayment to the following projects: (1) \$1,229,586.11 to loan to the Redevelopment Agency to pay off the principal portion of

the Caltrans note for the 252 Corridor Acquisition within the Southcrest Redevelopment Project Area, and (2) \$170,413.89 for the SEDC Business Development Program.

- 3. That an amendment to the Capital Improvement Budget is hereby approved to include Capital Improvement Program ("CIP") 52-416.0, entitled "Southcrest Redevelopment Area, 252 Corridor Land Acquisition"; authorizing the City Auditor to accept a \$164,906.48 loan repayment from the Redevelopment Agency, Mt. Hope Project Area; and appropriating these funds in the Capital Outlay fund to be loaned back to the Redevelopment Agency, Southcrest Project Area to be used to pay off the interest portion of the Caltrans note for the Acquisition of the 252 Corridor.
- 4. That the Auditor and Comptroller is hereby authorized to transfer \$274,683.73 from the Contribution to the Redevelopment Agency Fund, and \$1,229,586.11 from the 1990 CDBG funds, and \$164,906.48 from the Capital Outlay to the Redevelopment Agency for the purposes described above; and further authorized to transfer \$500,000.00 from the 1983 CDBG funds to the Southcrest Redevelopment Project Area, to be used for the principal portion of the Caltrans note for the Acquisition of the 252 Corridor; and further authorizing the Auditor to transfer \$8,715.09 from the Route 252 Acquisition Fund (10141), and \$175,848.67 from the Route 252 Mitigation Fund (10142) to the Redevelopment Agency, Southcrest Project Area, for the Caltrans note and the National City Mitigation Payments, respectively.

5. That the Auditor and Comptroller is directed to record the above disbursements to the Southcrest Redevelopment Project Area as interest bearing loans, to the Agency, to be repaid as soon as practicable, from tax increment or other revenues.
