RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, ADOPTING A MAP SHOWING THE PROPOSED BOUNDARIES OF A SPECIAL ASSESSMENT DISTRICT.

(Assessment District No. 4021 [De La Fuente Business Park II])

WHEREAS, the City Council of The City of San Diego, California, has been presented and has received a map showing and describing the boundaries of the area proposed to be assessed in an assessment district under the provisions and authority of the "Municipal Improvement Act of 1913," being Division 12 of the Streets and Highways Code of the State of California, and the San Diego Improvement District Procedural Ordinance of 1982, as applicable; said assessment district known and designated as ASSESSMENT DISTRICT NO. 4021 (DE LA FUENTE BUSINESS PARK, PHASE II) (hereinafter referred to as the "Assessment District"); NOW, THEREFORE,

BE IT RESOLVED, by the City Council of The City of San Diego as follows:

1. That the above recitals are all true and correct.
2. That a map of the Assessment District showing the boundaries of the proposed Assessment District and lands and property to be assessed to pay the costs and expenses of the proposed improvements designated as "PROPOSED BOUNDARIES OF

ASSESSMENT DISTRICT NO. 4021 (DE LA FUENTE BUSINESS PARK, PHASE II)" is hereby submitted and the same is hereby approved and adopted.

3. That the original map of said proposed boundaries of the proposed Assessment District and one copy thereof is to be filed in the office of the City Clerk.

4. A certificate shall be endorsed on the original and on at least one copy of the map of the Assessment District, evidencing the date and adoption of this resolution, and within fifteen (15) days after the adoption of the resolution fixing the time and place of hearing on the formation or extent of said Assessment District, a copy of said map shall be filed with the correct and proper endorsements thereon with the County Recorder, all in the manner and form provided for in Section 3111 of the Streets and Highways Code of the State of California.


