RESOLUTION NUMBER R- 279540

ADOPTED ON MAR 16 1992

WHEREAS, the City Clerk's office has implemented a pilot, non-partisan election education program for San Diego school children called YouthVote '92, whose goal is to increase participation in the electoral process by today's and tomorrow's voters; and

WHEREAS, to help achieve this goal, 5th, 8th and 12th grade students in The City of San Diego will have an opportunity to participate in mock elections on June 2, 1992, and November 3, 1992; and

WHEREAS, YouthVote '92 operates with the cooperation of the San Diego County Registrar of Voters and the San Diego Unified School District ("SDUSD"); and

WHEREAS, currently 13 schools and over 4,200 school children are a part of YouthVote '92; and

WHEREAS, to kick off the YouthVote '92 program, participating students have been encouraged to compete with other San Diego 5th, 8th and 12 graders in a writing/logo contest, with winners to be selected for each category at each grade level; and

WHEREAS, it is anticipated that prizes contributed by local businesses and organizations will be awarded as a Special Order of Business before the San Diego City Council on March 30, 1992; and

WHEREAS, the following businesses have generously donated prizes and cash to be used as prizes in the YouthVote writing/

logo contest for San Diego students: Action Kites, Aqua Adventures Kayak School, Bookstar, Cousins Warehouse, Eastman Kodak, The Fieldstone Foundation, H&M Landing, Ice Capades Chalet, Just SK8, Kaiser Permanente Medical Care Program, Kite Country, Pepsi Cola, Photo Imports, Police Officers Association, REI, Rubio's, San Diego Boys and Girls Clubs, San Diego Chargers, San Diego Host Lions Club, San Diego State University, San Diego Teachers Credit Union, Sea World, Suzy's Zoo, University of San Diego, Video Scene's Big Screen City, and Wells Fargo Bank; and

WHEREAS, Council Policy 100-2 requires Council approval of restricted gifts of personal property from multiple donors; NOW, THEREFORE,

BE IT RESOLVED that, with deep appreciation and gratitude, the City Council accepts the generous donations of prizes and gifts from the following companies: Action Kites, Aqua Adventures Kayak School, Bookstar, Cousins Warehouse, Eastman Kodak, The Fieldstone Foundation, H&M Landing, Ice Capades Chalet, Just SK8, Kaiser Permanente Medical Care Program, Kite Country, Pepsi Cola, Photo Imports, Police Officers Association, REI, Rubio's, San Diego Boys and Girls Clubs, San Diego Chargers, San Diego Host Lions Club, San Diego State University, San Diego Teachers Credit Union, Sea World, Suzy's Zoo, University of San Diego, Video Scene's Big Screen City, and Wells Fargo Bank;

BE IT FURTHER RESOLVED, that the City Clerk be authorized to

use these prizes and cash donations for the purpose of awarding prizes in the YouthVote '92 writing/logo contest for San Diego students.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is directed to establish a special revenue fund into which the donated cash shall be deposited, and that the Auditor and Comptroller is authorized to spend monies from that special revenue fund only for the purposes set forth in this resolution.
