RESOLUTION NUMBER R- 279544

ADOPTED ON MAR 16 1992

WHEREAS, Bay Terraces Community Park and Skyline Community Park are both in the Skyline - Paradise Hills Community Planning Area, with CIP No. 29-771.0, Bay Terraces Community Park - Children's Play Area scheduled for design in Fiscal Year 1992 and construction in Fiscal Year 1993; and

WHEREAS, the community effort to identify and prioritize projects for the 20 Year Needs List resulted in no listing for the Bay Terraces Community Park project; however, the Skyline Community Park Security Lighting project received a priority listing of 2 (a priority of 1 is the highest rating); and

WHEREAS, the proposed modification to the Fiscal Year 1992 Capital Improvements Program will provide an improvement desired by the community in lieu of a lesser project; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the title of CIP No. 29-771.0 is hereby changed from BAY TERRACES COMMUNITY PARK - CHILDREN'S PLAY AREA to SKYLINE COMMUNITY PARK - SECURITY LIGHTING; and the description of CIP No. 29-771.0 is hereby changed from providing a small children's play area at Bay Terraces Community Park to providing security lighting at Skyline Community Park.


