SUBJECT: Chateau Nord. CARMEL VALLEY COMMUNITY PLAN AMENDMENT (DEP No. 91-0472), CARMEL VALLEY PRECISE PLAN AMENDMENT, CARMEL VALLEY PLANNED DISTRICT ORDINANCE (PDO) AMENDMENT, VESTING TENTATIVE MAP (VTM No. 91-0553), and CARMEL VALLEY PLANNED DISTRICT DEVELOPMENT PERMIT (No. 91-0553) to redesignate the site from Neighborhood Commercial to Multi-family Residential and construct 39 condominiums on a previously graded 3.3 acre lot. The site is located on the north side of Quarter Mile Drive between El Camino Real and Wyndhaven Drive in the Community of Carmel Valley (A portion of the Northwest 1/4 of Section 18, T14S, R3W). Applicant: Pardee Construction Company.

- I. PROJECT DESCRIPTION: See attached Initial Study.
- II. ENVIRONMENTAL SETTING: See attached Initial Study.

III. DETERMINATION:

The City of San Diego conducted an Initial Study which determined that the proposed project could have a significant environmental effect. Subsequent revisions in the project proposal create the specific mitigation identified in Section V of this Mitigated Negative Declaration. The project as revised now avoids or mitigates the potentially significant environmental effects previously identified, and the preparation of an Environmental Impact Report will not be required.

The potential for significant impacts related to noise generated by traffic along El Camino Real has been mitigated through conditions contained in the Development Plan Permit.

IV. DOCUMENTATION:

The attached Initial Study documents the reasons to support the above Determination.

The following conditions in the Carmel Valley Planned District Development Permit (No. 91-0553) would mitigate potential impacts associated with noise.
