A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO CONSENTING TO A JOINT PUBLIC HEARING ON THE PROPOSED REDEVELOPMENT PLAN FOR THE CENTRE CITY REDEVELOPMENT PROJECT, AUTHORIZING THE ESTABLISHMENT OF A DATE, TIME AND PLACE THEREFOR, AND AUTHORIZING PUBLICATION AND MAILING OF NOTICE OF SUCH JOINT PUBLIC HEARING.

WHEREAS, the Redevelopment Agency of The City of San Diego (the "Agency") has prepared a proposed amended redevelopment plan for the Columbia, Marina and Gaslamp Quarter Redevelopment Projects (the "Project") to merge the Project areas and expand the boundaries of the merged Project within the Centre City area of San Diego, and to make certain other related revisions to the compiled redevelopment plan (the "Merger and Expansion Amendments"); and

WHEREAS, the compiled redevelopment plan which would be created by the proposed Merger and Expansion Amendments conforms to the requirements of the California Community Redevelopment Law (Health and Safety Code section 33000 et seq.); and

WHEREAS, the California Community Redevelopment Law authorizes a joint public hearing on the proposed Merger and Expansion Amendments to create the compiled redevelopment plan, with the consent of the Agency and the Council of The City of San Diego (the "Council"); and

WHEREAS, the Agency by resolution has consented to a joint public hearing on the proposed Merger and Expansion Amendments to

create the compiled redevelopment plan for the Project and has requested that the Council consent to such joint public hearing and establish the date, time and place therefor; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Council hereby consents to a joint public hearing with the Agency on the proposed Merger and Expansion Amendments to create the compiled redevelopment plan for the Project and hereby authorizes the City Clerk, in cooperation with the Executive Director of the Agency, or his designee, to establish the date, time and place therefor.

2. That The City of San Diego shall, by its designee and in cooperation with the Executive Director of the Agency, or his designee, publish and mail notice of public hearing on the proposed Merger and Expansion Amendments to create the compiled redevelopment plan, in the manner, and with other documents as required and established by law.


