

RESOLUTION NUMBER R- 279579

ADOPTED ON MAR 19 1992

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO ADOPT THE RECOMMENDATIONS OF THE CITY MANAGER TO SUPPORT THE EXPANSION AND RETENTION OF THE BIOTECHNOLOGY INDUSTRY IN SAN DIEGO.

WHEREAS, the Council of The City of San Diego directed the City Manager to bring forward recommendations to address the economic development needs of the City of San Diego; and

WHEREAS, the City Manager has identified the biotechnology industry as being a vital component to the industrial and economic base in San Diego; and

WHEREAS, the biotechnology industry is expected to substantially increase the employment base of the City; and

WHEREAS, the Council has recommended in Resolution No. RR-279293, adopted January 16, 1992, that action be taken to improve the employment and economic base of the City; and

WHEREAS, it is in the public interest that the recommendations be implemented; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that the Council hereby accepts the recommendations set forth in City Manager Report No. 92-97 dated March 16, 1992

BE IT FURTHER RESOLVED, by the Council that the Council hereby directs the City Manager to have a liaison from his office attend the general meetings of the BIOCUM and BIOMED Industry.

BE IT FURTHER RESOLVED, by the Council that the Council hereby directs the City Manager and the City Attorney to work with the environmental community and the industry to draft a resolution for Mayor and Council review a week before the Council hearing on April 6, 1992.
