RESOLUTION NUMBER R- 279599

ADOPTED ON MAR 23 1992

WHEREAS, the San Diego Police Department of the City of San Diego desires donations as funding of a City of San Diego "Gun Buy Back Program"; and

WHEREAS, the "Gun Buy Back Program" would be implemented and administered by the San Diego Police Department in all phases from purchase at the San Diego Pistol Range to destruction by the Police Department's Property Unit; and

WHEREAS, the San Diego Police Department desires to accept donations to the "Gun Buy Back Program" during the months of March and April, 1992; and

WHEREAS, the City Manager desires authorization to expend, at his discretion, up to twenty-five thousand dollars (\$25,000.00) in Federally Seized and Forfeited Assets funds (Fund 10132) to meet conditions of any donations which require other matching funds as a condition for contribution; and

WHEREAS, Council Policy 100-2 requires the City to maintain detailed trust records for multiple restricted donations; and

WHEREAS, the fiscal impact of the Program will be minimal since staffing will be provided by the Police Department on a non-overtime basis and private donations or seized and forfeited assets up to twenty-five thousand dollars (\$25,000.00) will fund the purchases of firearms; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego,

that the City Manager is hereby authorized and empowered to begin a "Gun Buy Back Program" to be administered by the San Diego Police Department which allows the Chief of Police to accept donations to that Program during the months of March and April, 1992.

BE IT FURTHER RESOLVED, by the Council of the City of San Diego, that the City Manager is hereby authorized to expend up to twenty-five thousand dollars (\$25,000.00) in Federally Seized and Forfeited Assets funds (Fund 10132) to meet conditions of any donations which require other matching funds as a condition for contribution.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to establish a special trust fund for donations to the "Gun Buy Back Program".

BE IT FURTHER RESOLVED, by the Council of the City of San Diego that all donations to the "Gun Buy Back Program" will be accepted with gratitude for the splendid expression of public service shown by each donor.
