
ADOPTED ON MAR 30 1992

BE IT RESOLVED, by the Council of The City of San Diego, that the offer of TRANSPORTABLE TREATMENT SERVICES, INC., is hereby accepted and the City Manager is hereby authorized to execute a contract for RENTAL OF FOUR (4) EACH TWO METER TRAILER MOUNTED FILTER BELT PRESSES with a qualified field technician for Fiesta Island as may be required for a period of eight (8) months beginning approximately April 1, 1992 through November 30, 1992 at a cost of \$49,500.00 per month for all four presses; terms net 30 days plus applicable sales tax, plus a total round-trip freight charge of \$12,880.00, plus \$3,500.00 for 40 hours of set up and training.

BE IT FURTHER RESOLVED, that the Purchasing Agent is hereby authorized to invoke the provisions of the San Diego Municipal Code, Section 22.0504 to obtain materials and services without advertisement in the case of a bona fide emergency affecting public health and safety.
