

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for INSTALLATION OF TRAFFIC SIGNAL INTERCONNECT ON UNIVERSITY AVENUE BETWEEN 40TH STREET AND ARAGON DRIVE.

BE IT FURTHER RESOLVED, that the expenditure of \$412,900.00 from CIP 68-008.0, ANNUAL ALLOCATION - TRAFFIC SIGNAL SUBSYSTEMS, Proposition "A", is hereby authorized solely and exclusively for

providing funds for said project and related costs, and
authorizing the Auditor and Comptroller upon advice from the
administering department, to retain excess budgeted funds, if
any, in CIP 68-008.0.
