APPROVING PARCEL MAP W.O. NO. 910183.


BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain parcel map surveyed by Jerome D. Moriarty, Registered Civil Engineer, entitled "PARCEL MAP W.O. NO. 910183, being a lot consolidation of Lots 1 to 48, inclusive, in Block 5, and Lots 1 to 48, inclusive, in Block 6 of Carmel Heights, in the City of San Diego, County of San Diego, State of California, according to the map thereof No. 1736, filed in the office of the Recorder of said County, September 8, 1922, which includes the alley adjoining said lots, as closed to public use, together with Bancroft Street as closed and vacated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said parcel map and the consolidation of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Nutmeg Street, and said portion of a street is hereby declared to be a portion of a public street and dedicated to the public use, as dedicated and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said parcel map, as and for the act of the Council and that said Council has

approved said parcel map, and that said portion of a street is accepted on behalf of The City of San Diego, a municipal corporation, as heretofore stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said parcel map to the Clerk of the Board of Supervisors of the County of San Diego, California.
