RESOLUTION NUMBER R- 279642

ADOPTED ON MAR 30 1992

A RESOLUTION DECLARING THE CONTINUED
STATE OF EMERGENCY REGARDING REPAIR
OF THE POINT LOMA OCEAN OUTFALL.

WHEREAS, Government Code section 8630 authorizes local governing bodies to proclaim local emergencies when such events occur as are defined by Government Code Section 8558(c), provided further by said Section 8630 that the local governing body must review the state of emergency every fourteen (14) days until the local emergency is declared terminated; and


WHEREAS, on February 5, 1992 the Council of The City of San Diego adopted Resolution No. R-279384 declaring the existence of a state of emergency concerning a rupture in the Point Loma Ocean Outfall; and on February 24, 1992 and March 16, 1992 the Council declared a continued state of emergency; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that pursuant to Government Code Section 8630, a continued state of emergency is declared to persist relative to the Point Loma Ocean Outfall.

BE IT FURTHER RESOLVED, that the measures previously taken by said Council in Resolution No. R-279384 shall continue to have full force and effect.
