
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is authorized and empowered to execute, for and on behalf of the City, an agreement with Beyaz & Patel, Inc. for as-needed engineering services to the Water Utilities Department Metro Division, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 279649, together with any reasonably necessary amendments or modifications thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time to carry out the purposes and intent of the project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$50,000.00 from Sewer Revenue Fund No. 41508, is hereby authorized, solely and exclusively for the purpose of providing funds for this project.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this agreement with tax exempt securities, if circumstances so warrant.
