BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$469,700 from the Clean Water Program Fund 41509, CIP No. 40-910.0, Mission Valley Effluent Pipeline, is hereby authorized, solely and exclusively to provide funds for this project, to be financed in the following manner:

\$117,425 from fiscal year 1992 appropriations

\$281,820 from fiscal year 1993 appropriations, contingent on approval of FY 1993 CIP budget

\$18,788 from fiscal year 1994 appropriations, contingent on approval of FY 1994 CIP budget

\$37,576 from fiscal year 1995 appropriations, contingent on approval of FY 1995 CIP budget

\$14,091 from fiscal year 1996 appropriations, contingent on approval of FY 1996 CIP budget.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this project with tax exempt securities, if circumstances so warrant.
