



BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to execute, for and on behalf of The City of San Diego, a 15-year lease agreement with NORKA INDUSTRIES, INC., for the use of approximately 17 acres of City-owned land in San Pasqual Valley for the operation of an ostrich ranch, at an initial annual rent of \$9,500, under the terms and conditions set forth in that lease agreement on file in the office of the City Clerk as Document No. RR- 279656.
