RESOLUTION NUMBER R- 279669

ADOPTED ON MAR 30 1992

WHEREAS, retired San Diegans depend upon their pension benefits to meet basic necessities such as food and shelter during their retirement years; and

WHEREAS, many fire fighters, police officers, teachers and other local, school and state employees depend on promised pension benefits, which must be protected from political abuse and misappropriation; and

WHEREAS, repeated misuse of pension funds undermines the dignity and security of all citizens who depend on pension funds for their retirement; and

WHEREAS, to protect pension systems, retirement board trustees must be free to administer the system solely in the best interest of the retirees; and

WHEREAS, the California Pension Protection Act, an initiative being co-sponsored by the Service Employees International Union (SEIU), would protect pension funds from misappropriation and ensure that retirement board trustees act in accordance with the best interests of their beneficiaries; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council does hereby endorse the proposed California

Pension Protection Act and encourages all San Diegans to support its passage.
