WHEREAS, the Council of The City of San Diego (the "City") has previously given its general approval to financing plans for the Central Imperial and Dells Imperial Redevelopment Study Areas of the Redevelopment Agency of The City of San Diego (the "Agency"); and

WHEREAS, the City has adopted the Fiscal Year 1991-92

Program Budget for the Southeast Economic Development Corporation

(SEDC); NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the Auditor and Comptroller is hereby authorized to accept a loan repayment of \$250,000 from the Redevelopment Agency, Gateway Center West Project Area; and to appropriate \$130,000 to be loaned back to the Redevelopment Agency, Central Imperial Study Area for costs to administer the study Area; and \$120,000 to be loaned back to the Redevelopment Agency, Dells Imperial Study Area for costs to administer the study area.
- 2. That the Auditor and Comptroller is hereby authorized to transfer \$250,000 from the Contribution to the Redevelopment Agency Fund (10227) to the Redevelopment Agency for the purposes described above.
- 3. That the Auditor and Comptroller is directed to record the above disbursements to the Central Imperial and Dells

Imperial Study Areas as interest bearing loans to the Agency, upon adoption of the study areas, to be repaid as soon as practicable from tax increment or other revenues.
