

RESOLUTION NUMBER R-279680

ADOPTED ON MARCH 31, 1992

WHEREAS, the National Estuary Program was established under the Clean Water Act of 1987 to promote long term planning and management in nationally significant estuaries threatened by pollution, development and overuse; and

WHEREAS, the United States Environmental Protection Agency has determined that the designation of additional estuaries to this program is warranted; and


WHEREAS, the designation of San Diego Bay as an estuary of national significance would benefit this entire area and provide federal assistance in protecting the bay; and

WHEREAS, the Environmental Health Coalition is attempting to have San Diego Bay so designated, and is supported by the California Regional Water Quality Control Board; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council hereby supports the efforts of the Environmental Health Coalition to obtain designation of San Diego Bay as an estuary of national significance.

BE IT FURTHER RESOLVED, that any state and federal programs mandated in connection with this designation will be paid for from the state and federal treasuries.
