RESOLUTION NUMBER R-279686


ADOPTED ON APRIL 2, 1992

WHEREAS, AB 2473, AB 3213 and AB 3214 are now due for consideration by the State Assembly; and

WHEREAS, these three bills if passed would have profound financial impacts on The City of San Diego, including the loss of \$1,100,000 in anticipated revenue; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that for and on behalf of its citizens, the Council expresses its strong opposition to AB 2473 (Burton), Water Pollution Fees; AB 3213 (Isenberg), Cigarette Fax Fund: allocations; and AB 3214 (Isenberg), Local Government Financing: property tax revenue allocation: special districts and school districts, and hereby directs the Department of Legislative Services, through the City's lobbyist, to immediately register such opposition with our state representatives.
