
RESOLUTION NUMBER R-279699

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of a grant deed of SHERI SNOW, ROBERT SNOW, LORI SNOW and RANDALL SNOW, executed in favor of The City of San Diego, a copy of which deed is on file in the office of the City Clerk as Document No. RR-279699, granting to said City an easement for public street purposes in Lots 7 and 8 of Block 1, Venice Park, Map No. 991, located between Pacific Beach Drive and Fortuna Avenue, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.
