BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute an agreement with the San Diego Consortium/Private Industry Council in the amount of \$148,000, a copy of which agreement is on file in the office of the City Clerk as Document No. RR-279707, for the purpose of carrying out the grant activities.

BE IT FURTHER RESOLVED, that the City Manager is hereby

authorized to expend \$3,000 in available State and \$4,000 in available Federal grant funds for miscellaneous related costs.
