
RESOLUTION NUMBER R- 279713

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a 5-year lease agreement, with an option for a 5-year extension and a conditional 180-day cancellation clause after the first 5 years of the lease term, with WAYNE BREISE, for Parcel 6 at Brown Field Airport, containing .40 acres of ramp for rental of aircraft storage hangars and tiedowns, at an initial annual rent of \$2,400 or various percentages of gross income, whichever is greater, under the terms and conditions set forth in that lease agreement on file in the office of the City Clerk as Document No.
