WHEREAS, the Council of The City of San Diego by Resolution Number R-279599 adopted on March 23, 1992, authorized and empowered the City Manager to begin a "Gun Buy Back Program" to be administered by the San Diego Police Department and;

WHEREAS, the Council of The City of San Diego further authorized the City Manager to expend up to twenty-five thousand dollars (\$25,000.00) in Federally Seized and Forfeited Assets Funds to meet the conditions of any donations which require other matching funds; and

WHEREAS, the City Manager desires further authorization to expend, at his discretion, up to twenty-five thousand dollars (\$25,000.00) in Federally Seized and Forfeited Assets Funds whether or not any donations are received to the program; NOW THEREFORE;

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to expend up to twenty-five thousand dollars (\$25,000.00) in Federally Seized and

Forfeited Assets Funds (Fund No. 10132) whether or not any donations or conditional gifts are received by the program.
