BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a First Amendment to Agreement with Motorola, Inc., for an 800 MHz Public Safety Communications System, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 279730, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.


BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$1,709,230 from CIP 33-495, the Public Safety Communications Project, to supplement funds previously authorized by Resolution No. R-27660, be and is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to transfer excess budgeted funds, if any, to the appropriate reserve.

BE IT FURTHER RESOLVED, that the City Manager be and is hereby authorized to finance all or parts of this project with General Obligation Bonds, if circumstances warrant.
