ADOPTED ON APR 06 1992

WHEREAS, the California Center on Victimology ("Center"), a nonprofit agency which provides assistance to crime victims and their families, has been a model for national victim, legal and counseling organizations; and

WHEREAS, the Center has been funded by The City of San Diego through a Victim Assistance Grant since 1987, as set forth in the Agreement on file in the office of the City Clerk as Document No. RR-268175-6; and


WHEREAS, the Center has ceased operation as of March 31, 1992 and a different nonprofit corporation has agreed to complete the final 90 days remaining on the project; and

WHEREAS, the original agreement between the Center and the City requires Council approval for any assignment of services; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered, for and on behalf of the City, to assign the contract with all rights and responsibilities now in effect with the California Center for Victimology to the California Crime Victim's Legal Clinic, Inc., under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR-279731.
