WHEREAS, American city problems can be overcome so American cities can strengthen the civility, beauty, and economic vitality and opportunity for all people; and

WHEREAS, what is required is increased public awareness about the status of America's cities, a new vision to achieve the highest standards for American city quality; and

WHEREAS, American city quality can be achieved through effective planning and management as well as through the efforts of individuals, businesses, schools and churches; and

WHEREAS, American City Quality Week is an annual, nationally designated week to focus public attention on improving the quality of our nation's cities and the values of city planning in the improvement process; and

WHEREAS, a decade-long program is being initiated to promote the planning and development of the highest quality American cities; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that April 7, through 13, 1992 be and it is hereby proclaimed to be "AMERICAN CITY QUALITY WEEK."

BE IT FURTHER RESOLVED, that citizens, businesses, schools, neighborhood organizations and other groups are urged to reflect on the status of America's cities, help shape a new vision and plan for our cities, form partnerships to achieve our plans and report to the nation on our accomplishments.
