BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to expend from Fund 100, Dept. No. 601, Org. No. 106, Account No. 4824, Job Order No. 060106 the sum of \$8,520 for the sole and exclusive purpose of paying attorneys fees and costs incurred in Henderson v. Abdelnour.
