

that the City Auditor and Comptroller is hereby authorized to
transfer \$150,000 in Community Development Block Grant (CDBG)
funds for the Gaslamp Revolving Loan Program from Fund 18502,
Org. 9544 to Fund 18527, Dept. 4013, Org. 1311, and to transfer
\$70,000 in CDBG funds from the CDBG Administration for the 1986
program from Fund 18522, Dept. 5860, Org. 6001 to Dept. 5866,
Org. 6606 and then to transfer the funds from Fund 18527, Dept.
4013, Org. 1311 and Fund 18522, Dept. 5860, Org. 6606 to the
Redevelopment Agency of The City of San Diego.

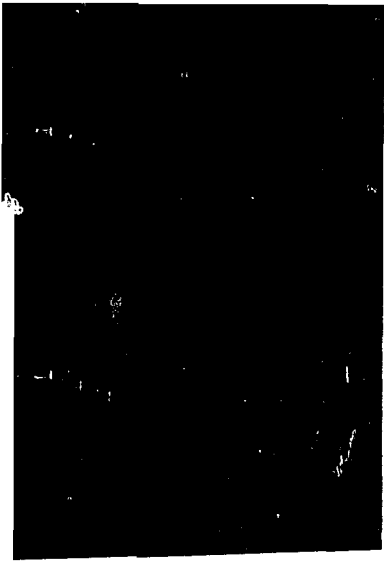
