RESOLUTION NUMBER R- 279743

ADOPTED ON APR 20 1992

WHEREAS, Dr. Jonas Salk wanted to establish a unique institution distinct from a university or a hospital, a facility where scientists could conduct their research free from the responsibilities of treating patients or teaching; and

WHEREAS, in 1960, Dr. Salk chose San Diego as the site for the Salk Institute for Biological Studies; and

WHEREAS, the Salk Institute has grown to become one of the four largest institutions for basic biological research in the world; and

WHEREAS, for over 30 years, scientists at the institute have contributed significantly to advances in biomedical research that have greatly improved the quality of human life; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council commends the Salk Institute's long-term commitment to the fundamental research necessary to the knowledge needed to create new ways to treat, and ultimately prevent heart disease, AIDS, and other diseases.

BE IT FURTHER RESOLVED, that Monday, May 11, 1992 be and the same is hereby designated "SALK INSTITUTE DAY" in San Diego.
