BE IT RESOLVED, by the Council of The City of San Diego that the specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT 33RD STREET AND ORANGE AVENUE, 61ST STREET AND IMPERIAL AVENUE, EUCLID AVENUE AND MONROE AVENUE AND AT FAIRMOUNT AVENUE AND TWAIN AVENUE, San Diego, California, on file in the Office of the City Clerk of San Diego, California on APR 20 1992, and bearing official document No.

W.O. 119789, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT 33RD STREET AND ORANGE AVENUE, 61ST STREET AND IMPERIAL AVENUE, EUCLID AVENUE AND MONROE AVENUE AND AT FAIRMOUNT AVENUE AND TWIN AVENUE.

BE IT FURTHER RESOLVED, that the expenditure, of \$400,000 from CIP No. 68-010.0 Annual Allocation - Construction Top 10-15 Prioritized Traffic Signals Fund 30300, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, in CIP No. 68-010.0.
