SUGGESTION: Mr. Amy was a Senior Water Utilities Supervisor at the time of submittal. He suggested providing and installing an above-ground 2000 gal. diesel tank and an above-ground 5000 gal. gasoline fuel tank at the Miramar Operations Station. The remainder of the award is \$795.13 and is based on savings of \$5,300.91.

DEPARTMENT: Fire  
AMOUNT: \$528.56  
SUGGESTION: Mr. Thompson was a Assistant Communication Officer at the time of submittal. He suggested having the Fire Department purchase an analyzer to extend the life of nicad batteries. The remainder of his award is \$528.56 and is based on savings of \$4,029.87.
