WHEREAS, the 1992 California Police Summer Games will be hosted in San Diego by the City of San Diego, the San Diego Police Department, and the San Diego Police Athletic Federation; and

WHEREAS, the California Police Summer Games have grown to be the second largest athletic event in the world behind the International Olympic Games; and

WHEREAS, more than 6,500 law enforcement competitors from throughout the State of California will participate; and

WHEREAS, The San Diego Police Athletic Federation has successfully hosted the 1967, 1972, 1980 and 1983 California Police Olympics, the 1987 World Police and Fire Games, and co-hosted the 1978 International Police Olympics; and

WHEREAS, we recognize the importance of promoting athletics, physical fitness, and morale among members of the law enforcement profession; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
that this Council, for and on behalf of said City, hereby
declares the week of July 4-12, 1992 to be 1992 California Police
Summer Games Week in San Diego.
