WHEREAS, the Lions Club of San Diego was chartered on April 8, 1922 with 55 members; and

WHEREAS, the San Diego District now has 64 Lions Clubs with a membership of over 2,100; and

WHEREAS, the Lions Club built, in 1948, a club house for the Blind Recreation Center in Balboa Park; and

WHEREAS, the Lions Club founded in 1963 the "Lions Optometric Vision Clinic" in Balboa Park which dispenses eyeglasses to needy individuals; and

WHEREAS, the Lions Club has granted over \$150,000 since 1964 to the Boys and Girls Aid Society, Ltd. of San Diego; and

WHEREAS, the Lions Club has been providing support and financial assistance since 1977 for the San Diego County for the Retarded; and

WHEREAS, the Lions Club constructed in 1982 the "Lions Community Center," an apartment building for senior citizens;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of its citizens, does hereby commend the San Diego Lions Club for 70 years of service to the community and for personifying their motto "We Serve."

BE IT FURTHER RESOLVED, that Saturday, April 11, 1992 be and the same is hereby designated "Lions Club of San Diego Day" in the City of San Diego.
