BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain parcel map surveyed by Ronald C. Parker, Licensed Land Surveyor, entitled "PARCEL MAP W.O. NO. 119987, being a division of Lot 3 of Eastgate Technology Park Unit No. 1, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 10830, filed in the office of the County Recorder of San Diego County, January 30, 1984," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said parcel map is in substantial conformance with the approved tentative map; that said parcel map and the division of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Towne Centre Court and a portion of Towne Centre Drive, and said street and a portion of street are hereby declared to be a public street and a portion of a public street and dedicated to the public use, as dedicated and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said parcel map, as and for the act of the Council and that said Council has

approved said parcel map, and that said street and portion of a street are accepted on behalf of the public as heretofore stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said parcel map to the Clerk of the Board of Supervisors of the County of San Diego, California.
