WHEREAS, the Council of The City of San Diego by Resolution Number R-279599 adopted on March 23, 1992, authorized and empowered the City Manager to begin a "Gun Buy Back Program" to be administered by the San Diego Police Department and;

WHEREAS, the Council of The City of San Diego further authorized the City Manager to expend up to twenty-five thousand dollars (\$25,000.00) in Federally Seized and Forfeited Assets Funds to meet the conditions of any donations which require other matching funds; and

WHEREAS, the Council of The City of San Diego by Resolution Number 279729 adopted on April 6, 1992, further authorized the City Manager to expend up to twenty-five thousand dollars (\$25,000.00) in Federally Seized and Forfeited Assets Funds whether or not any donations or conditional gifts are received by the program, and

WHEREAS, the City Manager desires further authorization to expend, at his discretion, an additional twenty thousand dollars (\$20,000.00) or a total amount of forty-five thousand dollars (\$45,000.00) in Federally Seized and Forfeited Assets Funds for the "Gun Buy Back Program" whether or not any donations are received by the program; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to expend at his

discretion, an additional twenty thousand dollars (\$20,000.00) or a total amount up to forty-five thousand dollars (\$45,000.00) in Federally Seized and Forfeited Assets Funds whether or not any donations or conditional gifts are received by the program.
