BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for THE EXPANSION AND MODERNIZATION OF TRAFFIC SIGNAL MASTER CONTROL SYSTEM.

BE IT FURTHER RESOLVED, that the expenditure of \$418,700.00 from CIP 68-007.0, TRAFFIC SIGNAL MASTER CONTROL SYSTEM EXPANSION, and \$150,000.00 from CIP 68-008.0, TRAFFIC SIGNAL SUBSYSTEMS, is hereby authorized solely and exclusively for

providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, in CIP 68-008.0.
