BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of a grant deed of LA JOLLA COUNTRY DAY SCHOOL, a nonprofit California corporation, executed in favor of The City of San Diego, bearing date of June 19, 1991, a copy of which deed is on file in the office of the City Clerk as Document No. RR-279819, granting to said City an irrevocable right to dedicate to public street purposes all that real property described as a portion of Lot 1 of Prospect Acres, Map No. 3803, and a portion of Pueblo Lot 1317 of the Pueblo Lands of San Diego, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby set aside for a future public street.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.
