RESOLUTION NUMBER R- 279822

ADOPTED ON APR 27 1992

WHEREAS, April 1992 marks the twenty-fourth anniversary of the Civil Rights Act of 1968 which guarantees equal housing opportunities for all; and

WHEREAS, there are powerful laws at the state and national level which prohibit discrimination in the sale, rental, marketing or financing of housing; and

WHEREAS, it is the solemn and sworn duty of government at all levels to protect and defend the rights of all its citizens and oppose housing discrimination whenever and wherever it occurs; and

WHEREAS, The City of San Diego, in its commitment to equal access, has adopted policies on affirmative marketing and balanced communities; and

WHEREAS, despite all of the laws and policies, segregated housing patterns and barriers to equal housing access still remain; and

WHEREAS, the Fair Housing Community strives to promote education through an Annual Fair Housing and Public Education Seminar; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, hereby proclaims April 1992 to be "FAIR HOUSING MONTH" in San Diego, and commends the many individuals and organizations who

continue to play a key role in the elimination of illegal housing  
discrimination in the City of San Diego.
