BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the California Department of Transportation, for the construction of the Mira Mesa Boulevard/Miramar Road Traffic Signal System, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 279829.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to accept for and on behalf of said City, a 1992 Traffic Systems Management Plan grant from the California Department of Transportation in the amount of \$1,272,000 for the Mira Mesa Boulevard/Miramar Road Traffic Signal System.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to establish Capital Outlay Grant Fund No. 38513, "Mira Mesa Boulevard/Miramar Road Traffic Signal System."



not to exceed \$1,272,000 from CIP No. 63-013.0, is hereby
authorized, solely and exclusively for the purpose of providing
funds for the above project.
