RESOLUTION NUMBER R- 279836

ADOPTED ON APR 27 1992

WHEREAS, the Council of The City of San Diego has adopted an urban water management and conservation plan to include the retrofiting of mobile home showerheads as one of its programs; and

WHEREAS, such a program would promote permanent water savings through the installation of low-flow showerheads and would be similar to the program implemented for single-family homes; and

WHEREAS, the San Diego County Water Authority is willing to cooperate in the implementation of such a program in the City of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized to implement a Mobile Home Showerhead Retrofit Program.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to execute, for and on behalf of the City, an agreement with the San Diego County Water Authority, to implement such a Mobile Home Showerhead Retrofit Program, under the terms and conditions set forth in the Memorandum of Understanding, a copy of which is on file in the office of the City Clerk as Document No. RR- 279836.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$40,000 from Water Utilities Department Operating Fund (No. 41500), Water Conservation Program (70622), is hereby authorized, solely and exclusively for the purpose of providing funds for the above program.
