BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to execute, for and on behalf of the City, an agreement with the San Diego County Water Authority, to implement such a Mobile Home Showerhead Retrofit Program, under the terms and conditions set forth in the Memorandum of Understanding, a copy of which is on file in the office of the City Clerk as Document No. RR- $\frac{279836}{}$

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$40,000 from Water Utilities Department Operating Fund (No. 41500), Water Conservation Program (70622), is hereby authorized, solely and exclusively for the purpose of providing funds for the above program.
