ADOPTED ON APR 27 1992

A RESOLUTION OF THE CITY OF SAN DIEGO ADOPTING THE SEVEN-YEAR TRANSNET LOCAL STREET AND ROAD PROGRAM OF PROJECTS FOR FISCAL YEARS 1993 THROUGH 1999, CITY MANAGER'S REPORT NO. 92-100, AND AMENDING THE FISCAL YEAR 1992 TRANSNET LOCAL STREET AND ROAD PROGRAM OF PROJECTS.

WHEREAS, on November 3, 1987, the voters of San Diego County approved the San Diego Transportation Improvement Program Ordinance and Expenditure Plan; and

WHEREAS, the Ordinance provides that the San Diego County
Transportation Commission shall annually approve a program of
projects submitted by local jurisdictions identifying those
transportation projects eligible to use transportation sales tax
(TransNet) funds; and

WHEREAS, the City of San Diego was provided with an estimate of annual TransNet local street and road revenues for fiscal years 1993 through 1999; and

WHEREAS, the City of San Diego wishes to amend the Fiscal
Year 1992 list of City projects within the 1990-97 TransNet
Program of Projects to reflect the final Fiscal Year 1992 City of
San Diego budget.

WHEREAS, on April 27, 1992, the City of San Diego held a public hearing in accordance with Section 5(A) of the Ordinance; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, (the "Council"), that the Council does hereby adopt the attached seven-year program of projects to be funded in part with local street and road TransNet revenues for inclusion in the 1992-1999 TransNet Program of Projects.

BE IT FURTHER RESOLVED, that the Council does hereby amend Fiscal Year 1992 list of City projects contained within the 1990-1997 TransNet Program of Projects.

BE IT FURTHER RESOLVED, that pursuant to Section 8 of the TransNet Ordinance, the Council certifies that the required minimum annual level of local discretionary funds to be expended for street and road purposes will be met throughout the seven-year period consistent with Maintenance of Effort Requirements adopted by the SANDAG Commission on June 24, 1988.

BE IT FURTHER RESOLVED, that pursuant to Section 9 of the TransNet Ordinance, the Council certifies that TransNet funds programmed in the attached Seven-Year Program of Projects do not replace private developer funding which has been or will be committed for any project.

BE IT FURTHER RESOLVED, that pursuant to Section 16 of the TransNet Ordinance, the Council certifies that each project of \$250,000 or more will be clearly designated during construction with TransNet project funding identification signs.

BE IT FURTHER RESOLVED, that the Council does hereby certify all other applicable provisions of the TransNet Ordinance have been met.
