## RESOLUTION NUMBER R- 279846 ADOPTED ON APR 27 1992

WHEREAS, The City of San Diego adopted a policy on solid waste recycling which established a goal of recycling a minimum of 25% of the total solid waste generated within the City by July 1992; and

WHEREAS, City is required to meet the mandates of State legislation in the area of solid waste management; and

WHEREAS, City, through a joint Request for Proposal process with the County Department of Public Works, has selected the lowest responsible bid of I Love a Clean San Diego County, Inc. ("ILACSDC, Inc.") as the vendor for Waste Management Department's public education, information, and referral service needs; and

WHEREAS, ILACSDC, Inc. has a community based program with goals which include litter reduction, resource conservation, recycling, proper disposal of solid waste leading to community beautification through a voluntary partnership of schools, civic and neighborhood groups, government agencies, business and industry; and

WHEREAS, ILACSDC, Inc., is recognized within the community as a major source of information regarding solid waste issues; and

WHEREAS, the programs to be accomplished by ILACSDC, Inc., are of such a nature that the interests of the City are better served by an agreement with ILACSDC, Inc. than by the performance

of such programs by the City; and

WHEREAS, the agreement between the City and ILACSDC, Inc., is for one year with four one-year options for renewal and will allow the City Manager or his or her designee to extend the agreement from month-to-month, for up to three months, if required; the agreement is effective retroactively on February 1, 1992, and will extend through January 30, 1993; NOW, THEREFORE,

that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with I Love a Clean San Diego, Inc, to provide vendor services for the Waste Management Department's public education information and referral services, and for the expenditure of \$156,131 from the Waste Management Department budget, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-279846, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.
