
BE IT RESOLVED, by the Council of The City of San Diego that EAST COUNTY PIPELINE CONSTRUCTION, INC. is to be declared a nonresponsible bidder as regards the CONSTRUCTION OF UNIVERSITY AVENUE STORM DRAIN BETWEEN ALBATROSS STREET AND FRONT STREET, and that their bid for this project be rejected on that basis.

BE IT FURTHER RESOLVED, by the Council of The City of San Diego that the second low bid of RTB GENERAL ENGINEERING COMPANY, INC. a corporation, be accepted and a contract be authorized for the CONSTRUCTION OF UNIVERSITY AVENUE STORM DRAIN BETWEEN ALBATROSS STREET AND FRONT STREET, in the amount of \$71,185.70, which is 18.6% over the estimate of \$60,000.00.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$40,000.00 from CIP 58-004, ANNUAL ALLOCATION - MISCELLANEOUS REQUIREMENTS - CITY STREETS, TransNet Fund 30300, CIP 11-297.0, CONSTRUCTION OF UNIVERSITY AVENUE STORM DRAIN BETWEEN ALBATROSS STREET AND FRONT STREET, and authorizing the expenditure of \$40,000.00 from CIP 11-297.0 to supplement Resolution No. R-278543 for \$100,000.00 for a total of \$140,000.00.
