BE IT FURTHER RESOLVED, that the City Council hereby agrees and further does authorize the City Manager to certify that the City will comply with all applicable state and federal statutory and regulatory requirements related to any federal or state grant received, including but not limited to the Assurances contained in the Federal Grant Application and the State Grant Contract; the Freedom of Information Act, 5 U.S.C. 552, as amended, relating to the right of the public to obtain information and records; the National Historic Preservation Act of 1966, as amended, relating to the preservation of historic landmarks; the Copeland (Anti-Kickback) Act, 18 U.S.C. 874, 40 U.S.C. 276c, and the regulations issued thereunder; 29 C.F.R. 3.1 et seq.;

and the Contract Work Hours and Safety Standards Act, 40 U.S.C. 327 et seq., and the regulations issued thereunder.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute the resultant grant agreements and any amendments thereof for the purpose of securing the grant funds.
