ADOPTED ON MAY 04 1992

WHEREAS, the Latino City Employees Association, Los Bomberos de San Diego (Firefighters), the Latino Peace Officers Association, the Metropolitan Latino Peace Officers Association, and The City of San Diego Human Relations Commission have expended great efforts in sponsoring the City's first Cinco De Mayo Celebration; and

WHEREAS, this year's Cinco de Mayo marks the one hundred thirtieth anniversary of the Battle of Puebla, fought on May 5, 1862, which inspired an upsurge of national feeling in Mexico and stood as a symbol of freedom to sustain the Mexican people through the following years of French rule, and currently is a day of recognition for Mexican-Americans with roots and culture reaching back to that historic event; and

WHEREAS, this City celebration will include a multi-media art exhibition in the City Hall lobby, cultural dancers in the Community Concourse Plaza, and a presentation on Latino History in San Diego in the Council Committee Room; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, hereby proclaims May 4-8, 1992, to be "CINCO DE MAYO CELEBRATION WEEK" in San Diego, and encourages all residents and City

employees to attend the festivities and enjoy the cultural significance of this celebration.
