BE IT RESOLVED, by the Council of The City of San Diego, that the Council hereby approves the recommendations jointly developed by an ad hoc task force from the City, the Convention and Visitor's Bureau, and the Hotel Motel Association for the implementation of the Major Events Revolving Fund Program as stated in City Manager's Report No. 91-462.

BE IT FURTHER RESOLVED, that the implementation criteria for the Major Events Revolving Fund shall include the additional recommendation that the fund ceiling be increased to a goal of \$3 million and that a minimum \$250,000 TOT funds be allocated annually to the fund in the early years of the program.
