BE IT FURTHER RESOLVED, that the City Manager of the City of San Diego be, and he is hereby authorized to enter into a contract with Nissan Motor Corp., U.S.A., for the purchase of ten (10) 1992 Nissan Pathfinders SE-V6 at a cost of \$10,774.00 each and nine (9) 1992 Nissan Kingcab SE-V6 pickups at a cost of \$7,764 each and \$8,502.50 for costs associated with painting the vehicles according to Lifeguard Services specifications, for a combined total cost of \$186,118.50, plus sales tax of \$14,424.18.

BE IT FURTHER RESOLVED, that the expenditure, of \$215,742.68 from Equipment Division Replacement Fund #50031 for this purpose and subsequent fitting costs. Of this amount, \$132,452.68 will be advanced to the General Fund from Equipment Division Replacement Fund and recovered over a period of three (3) years increasing the normal vehicle assignment charges by approximately
